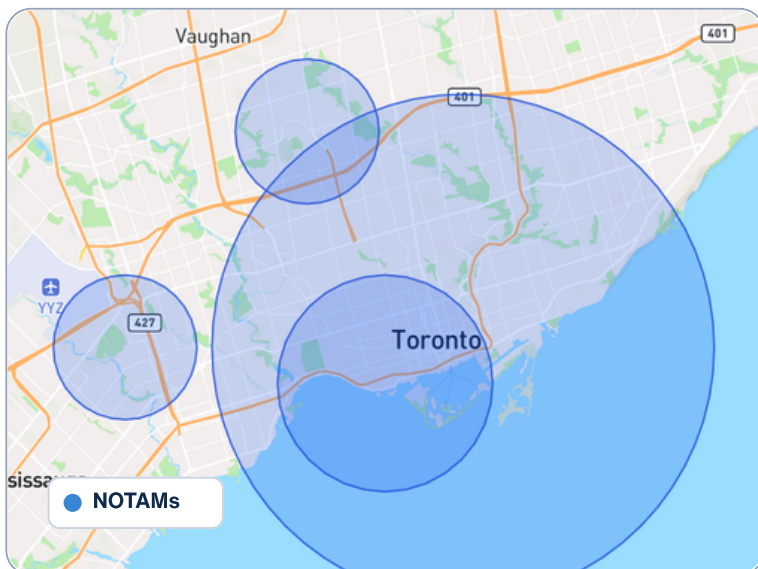

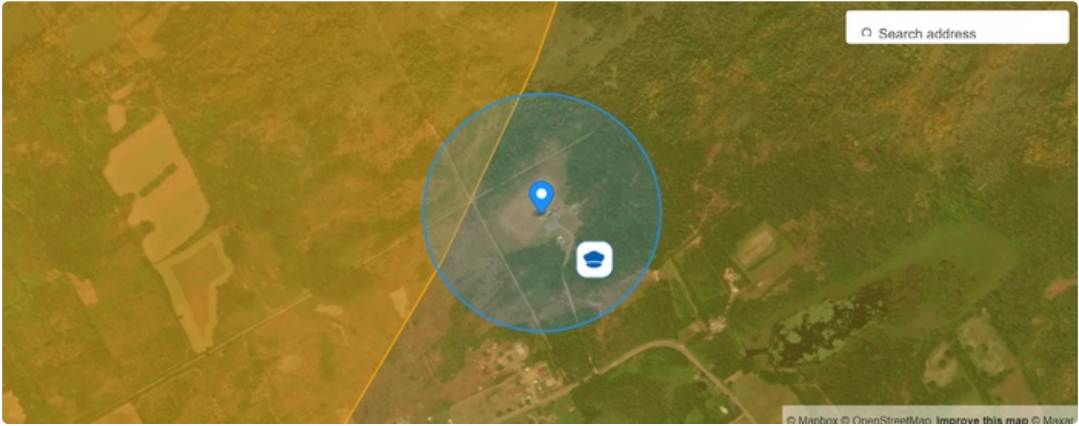

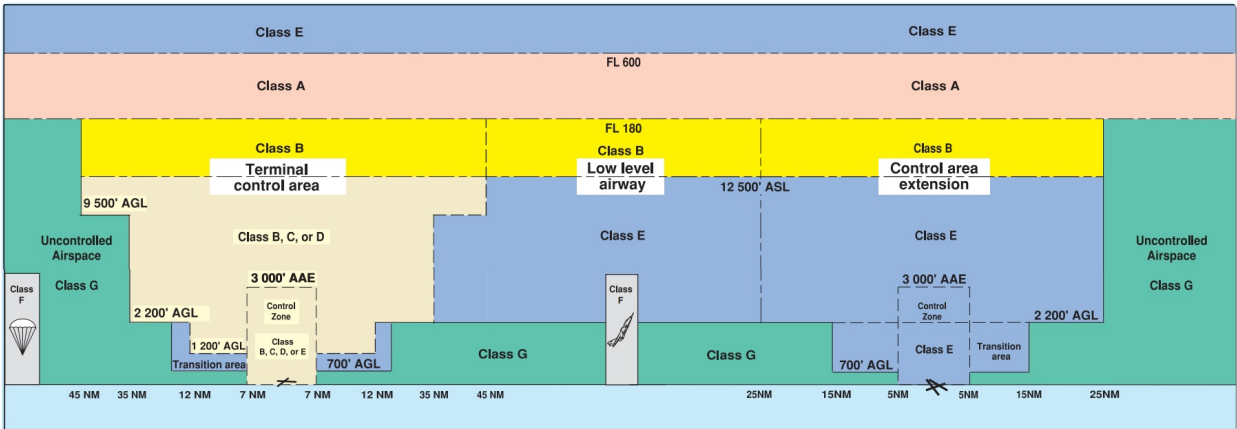

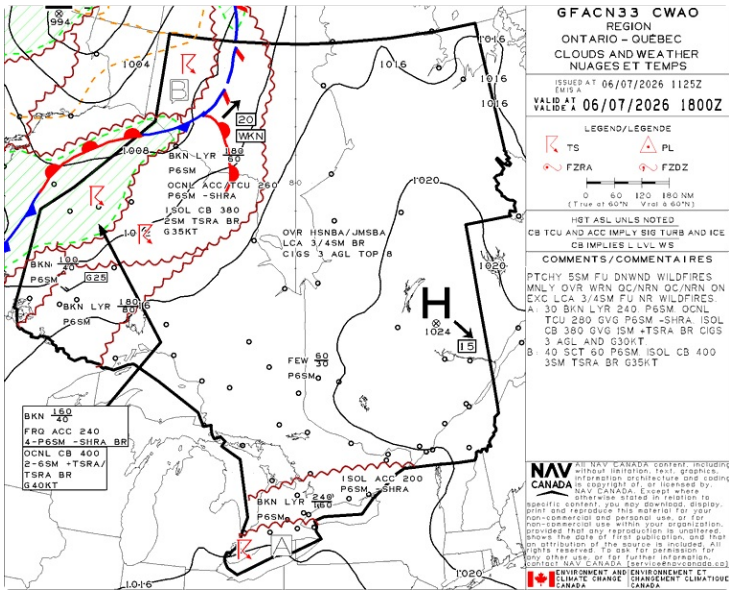
TURBULENCE, ICING AND FREEZING LEVEL



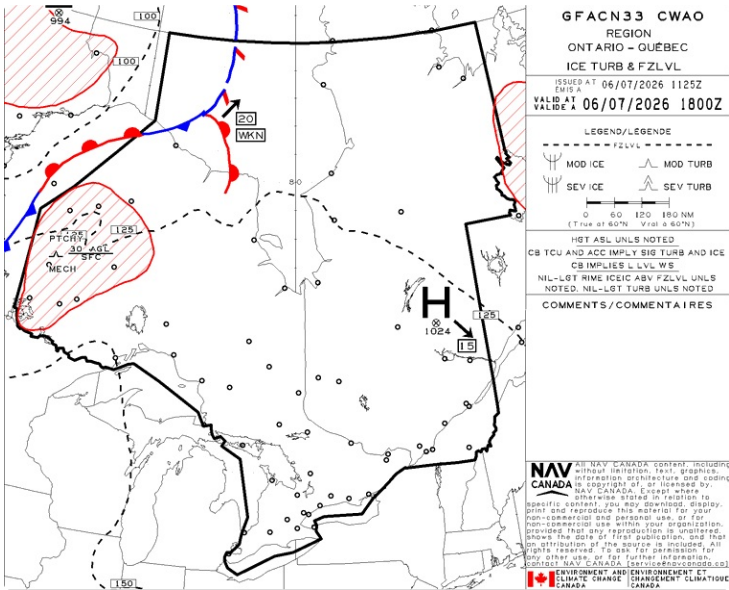

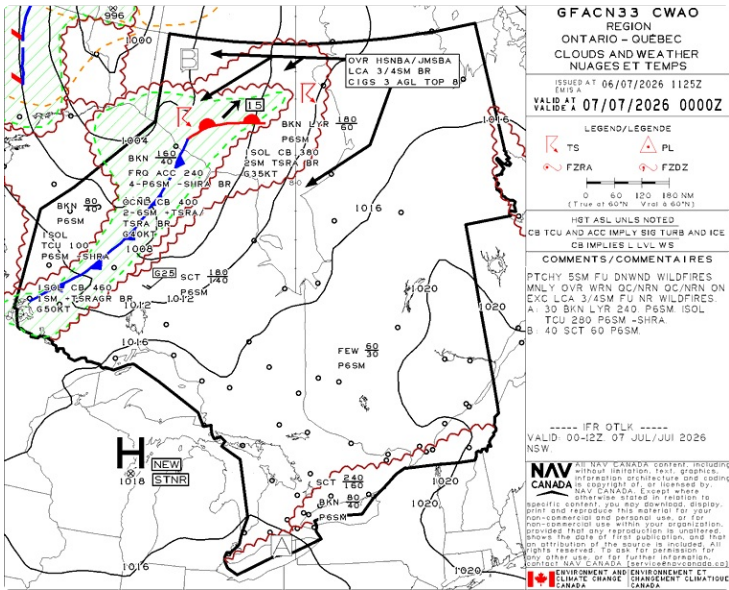

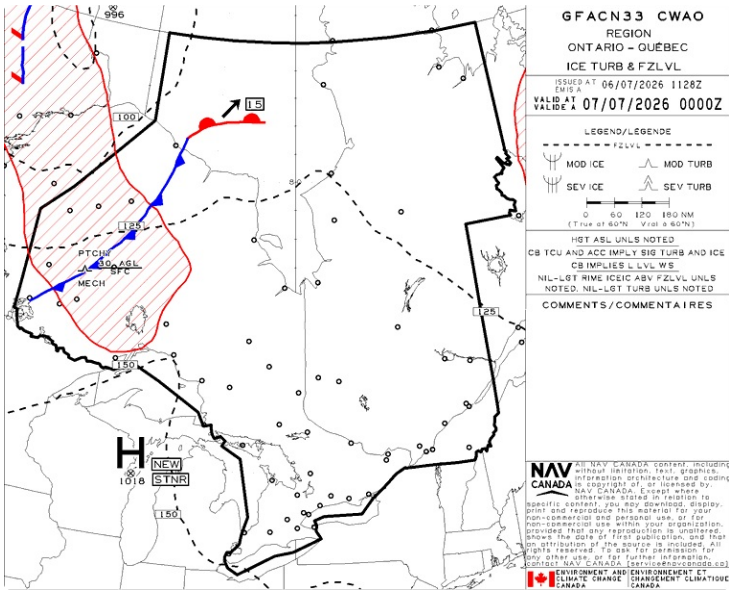
Graphical Area Forecast
